5. PRIVACY NOTICE

This privacy notice explains how St Albans City & District Council (the Data Controller) will use any personal information we collect about you when you use our services.

What information do we collect about you?

The information that the Council will collect varies depending on how you use the Council's Services. We are using the information provided in this case for a public task (Art. 6(1)(e)GDPR). This means we collect your personal information from you so that we can carry out our statutory functions. In this case we are collecting personal information so that we can consider your application for temporary road closures under the Town Police Clauses Act 1847.

How will we use the information about you?

We use the information to consider your application. We may share the information with other departments at the Council to enable us to do this. The other departments will include Legal and Community Services, but it may also include other departments where necessary. We will only share the information to enable us to deal with this matter.

We will share the personal information we hold with partner organisations. By partner organisations we mean the Police Constabulary and Highway Authority where sharing your data is necessary to consider the temporary road closures. We may be required to share your personal information with the Police, Internal Audit or similar agency, or another Council for the purposes of preventing and detecting fraud.

We will ensure that all personal information is kept securely.

How long will we keep this information?

We will destroy this personal information in accordance with our Disposal Schedules. We consider what the legislation states and what is good practice to determine how long we need to keep your information. This means we will securely destroy the information once we no longer need it. Individuals' Rights

You have a right to request a copy of the personal information that we hold about you. If you would like a copy of some or all of your information, please contact foi@stalbans.gov.uk and ask for a subject access request.

If you consider we hold inaccurate personal information about you, you can contact us to ask for this information to be corrected.
