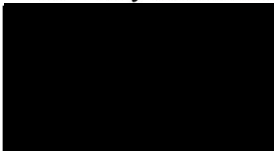

It would be helpful if you will bring with you details of each of the events that have caused concern, including the following information and any other details you consider relevant:

1. exactly where the incident(s) arose and what is the issue complained of
2. what time of day or night the incident(s) occurred (as close as you can pinpoint)
3. for each incident do you consider it was malicious vandalism or an accident (although I understand this is both annoying and expensive)
4. for each occasion whether the police were called/contacted
5. broadly what the reaction of the police has been (you have already indicated that has been raised at Neighbourhood Watch meetings).
6. whether the matter been raised at regular Police Community meetings in Redbourn, with the Parish Council or with local Councillors.
