We have been concerned by the recent history of branches failing during winds and snow loading. The highway below is used by local traffic and parked cars. It's also used as a thoroughfare for local school children. 2. We know of at least one occasion where a fallen branch has hit a car and have documented recurring problems where large branches have blocked the road and the pavement. We are especially concerned as Churchill Road is unlit most of the night so fallen branches may not be apparent to pedestrians and fallen branches present a trip hazard. 3. The tree is disproportionately large compared to surrounding properties. We understand this is a forest tree and in our opinion unsuitable for a residential location. 4. We are concerned the tree is unstable and a potential danger. A visual inspection shows the roots to be clearly restricted by a walled drop. The canopy is enormous by comparison. 5. We are concerned about damage to services, principally water mains damage caused by the tree roots. 6. Areas of retaining wall seem to have been damaged and are undulating worryingly. 7. We suspect damage to pathways, both on our land and on the public highway. 8. We believe the tree is not suitable for the current location. 9. We do not believe the existing tree is viable in the long term. We therefore contacted a specialist who advised: My recommendation is to fell the Douglas fir tree as soon as practicable and grind out the stump, then replace with a more suitable species for this location; this is due to the recent history of large branch/limb failure where on three recent occasions branches have landed on the footpath, road and even parked cars.
