# LISTED BUILDING ENFORCEMENT NOTICE (Unauthorised Works)

# WHEREAS:

(1) The building situated at and known as Thai Square, 26A-28 George Street, St Albans, Hertfordshire, AL3 4ES

shown edged red on the attached plan is a listed building as defined in Section 1 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

(2) The building is situated within the district of the St Albans District Council ("the Council"), being the local planning authority for the purposes of the Act.

(3) It appears to the Council that the following works, specified in Schedule 1 ("the said works") have been carried out to the building and that the said works involve a contravention of Section 7 of the Act in that the said works are for the alteration of a listed building in a manner affecting its character as a building of special architectural or historic interest and the said works are not authorised under the Act, no listed building consent having been granted therefore.

(4) The Council consider it expedient, having regard to the effect of the said works on the character of the building as one of special architectural or historic interest, to issue this notice.

(5) **NOTICE IS HEREBY GIVEN** that, in exercise of their powers under Section 38 of the Act, the Council require that the steps specified in Schedule 2 hereto be taken to restore the building to its former state within the period of 28 days from the date on which this notice takes effect.

(6) **THIS NOTICE SHALL TAKE EFFECT,** subject to the provisions of section 39(2) of the Act, on 22 August 2023.

#### SCHEDULE 1

The said works that have been carried out to the Building.

The installation of air conditioning and heating units and associated servicing and metal structural supports onto the Grade II\* listed building. The units and associated servicing and metal supports have numerous fixings into the historic fabric of the building including the C15 timber frame and wattle and daub panels.

#### SCHEDULE 2

The works to restore the building to its former state.

Specified Steps required to address the Breach of Listed Building Control

- i. Remove condenser units and associated servicing in the rear yard.
- ii. Remove the air conditioning units, associated servicing and wall heaters to the first floor and all of the metal cable trays and cassettes and associated fixings and supports to the first floor.
- iii. Make good any damage to the Building to match the existing original work adjacent, undisturbed by the unauthorised works, in respect of materials used, detailed execution and finished appearance.
- iv. Remove from the land (as per site plan in this report and outlined in red, located in appendix 1) all rubble and building materials arising as a result of compliance with step (i), (ii), and (iii) above.

#### ANNEX 1

The Council consider it expedient to issue the attached Listed Building Enforcement Notice under Section 38 of the Planning (Listed Buildings and Conservation Areas) Act 1990 for the following reasons:-

- 1. It appears to the Council that the above breach of listed building control has occurred.
- 2. The alterations to the Grade II\* listed building have caused less than substantial harm to its special architectural or historic interest. The installation of the air conditioning and heating units and associated servicing and metal structural supports has caused harm to the significance of the Grade II\* listed building. The units and associated servicing and metal supports have numerous fixings into the historic fabric of the building including the C15 timber frame and wattle and daub panels. The units and associated servicing and metal supports are a prominent and discordant feature and compete with the C15 timber framing. The harm caused is not outweighed by any public benefit in this case.
- The works are contrary to Policy 86 (Buildings of Special Architectural or Historic Interest) of the adopted St Albans City and District Local Plan Review 1994 and Chapter 16 of The National Planning Policy Framework (NPPF).


# Your Right of Appeal

#### What Happens If You Do No Appeal




