# Privacy Notice for Applications to Trade at St Albans Street Festivals 2022

This privacy notice explains how St Albans City & District Council (the Data Controller) will use any personal information we collect about you when you use our services.

# What information do we collect about you?

The information we will collect will vary depending on how you use the Council's Services. We collect personal information you agree to share with us voluntarily so that you can join the St Albans City & District Community Engagement Traders Mailing List [Art.6(1)(a) UK General Data Protection Regulations ("UK GDPR")]. You will be asked to provide your contact details as well as non-personal information such as your business details and certificates.

## How will we use the information about you?

If you complete this form the information you provide will be used to enable you to trade at the Council operated Community Events. We will then use your information to contact you to invite you to complete a form for our future events. We may be required to share your personal information with the Police, or similar agency, or another Council for the purposes of preventing and detecting fraud. We will ensure that all personal information is kept securely.

## How long will we keep this information?

We will destroy this personal information in accordance with our Disposal Schedules. This means we will securely destroy the information once we no longer need it. ## Individuals' Rights

You have a right to request a copy of the personal information that we hold about you. If you would like a copy of some or all of your information, please contact foi@stalbans.gov.uk and ask for a subject access request.

If you consider we hold inaccurate personal information about you, you can contact us to ask for this information to be corrected. You can ask us to stop processing your personal information at any time by emailing <u>festivaltraders@stalbans.gov.uk</u>. You have the following rights in respect of the information you have consented to share with us:

- To be forgotten i.e. your details will be deleted
- To have us correct an error
- To have us restrict the way we use the information
- To object to us using the information
- To have your information shared at your request (data portability)
