

Have your say in May

Elections for St Albans City and District Council will take place on Thursday 2 May – along with an election for the Hertfordshire Police and Crime Commissioner.

Eighteen District Council seats – around a third of the total - will be contested, that is one in each ward except Colney Heath and Redbourn. People from across the county will be voting in the Police and Crime Commissioner election.

Poll cards will be issued in late March and voters are asked to check their polling station as there may be a change.

To have your say in May, make sure that you are registered to vote, especially if you have recently changed address. The deadline to register for the elections is Tuesday 16 April.



Remember, I need photo ID to vote

Voter ID

Voters are reminded they will need to show approved photo ID to vote at a polling station. This includes a current or expired UK passport or driver's licence.

Anyone who does not have one of the accepted forms of ID can apply for free ID known as a Voter Authority Certificate.

The deadline to apply for a Voter Authority Certificate for the elections is 5pm on Wednesday 24 April.

Action against fly-tippers

We recently traced and prosecuted two fly-tippers at St Albans Magistrates Court.

One company, which admitted dumping rubbish near Redbourn, was ordered to pay more than £7,000 in fines and costs.

A 37-year-old man who dumped the contents of a house clearance beside a farm gate near Wheathampstead was ordered to pay £544 and complete 150 hours of community service.

In addition, we have raised the maximum Fixed Penalty Notice fine for a fly-tip from $\pounds400$ to $\pounds1,000$. The maximum for failure to check if a waste removal firm has the required licence is now $\pounds600$.

The Council issued more than 60 of these fines last year with fly-tips not only being an eyesore, but a potential health hazard and costly to clear up.

Herts Film Office




We are supporting the recently formed

Bodycams for CEOs

Our Civil Enforcement Officers, formerly known as traffic wardens, have been equipped with body-worn cameras while out on patrol.

The cameras will help deter verbal and physical abuse of the officers as they will provide police with evidence of any serious incidents.

Police, other local authorities, the security industry and many businesses have used this type of camera for some years.

Measures to protect people's privacy and uphold data protection rules are fitted onto the devices.





Charter Market's national award

The Market was praised for the support given to traders and for creating a lively atmosphere in the City Centre.

More than 3 million unvaccinated children are at risk of catching measles in England

Make sure your child is up to date with their MMR vaccinations

Measles warning

There is growing concern about an increase in cases and outbreaks of measles across England.

The vast majority of cases involve children who have not had the MMR vaccine.

Measles is an infection that spreads very easily and can cause problems in some people, so it is important to ensure you keep up to date with children's vaccines.

You can do so by checking a child's Red Book, by contacting their GP or by the NHS app.

For every £1 you pay in Council Tax

Hertfordshire County Council will get **77p Total £107.9m** Hertfordshire Police and Crime Commissioner will get **11p Total £16.1m** St Albans City and District Council will get **9p Total £12.9m** Parish Councils will get **3p Total £3.8m**

On average, you will pay just **£3.88 a Week** for all the services provided by your District Council including:

- Refuse and various recycling services
- Parks and leisure services
- Street cleaning
- Museums
- Parking control
- Planning and enforcement
- Housing and benefit advice
- Tackling crime and nuisances like fly-tipping, noise and dog mess
- Elections
- Special events and festivals
- Sustainability initiatives
- Food, health and safety inspectors



How Council Tax is calculated

The Council's funding comes from a number of sources including Council Tax. The Council's gross expenditure of £42.8m is the main determinant of the level of Council Tax after allowing for expected income.

Charges, and why they vary between areas

St Albans City and District Council also collects Council Tax on behalf of Hertfordshire County Council, Hertfordshire Police and Crime Commissioner and the Town and Parish Councils in the District.

The actual charge for each band varies from area to area. This is because certain services are provided by the District Council in some areas, but by the Town or Parish Council in others.

Town and Parish Councils have the freedom to set their own precepts. The amount you pay depends on where you live.

Becoming Us: African Caribbean St Albans, until Sunday 30 June, Keeper's Galleries, St Albans Museum + Gallery, until Sunday 30 June, Free.

This exhibition, co-curated by Active Lifestyles and LeeAnna's Wish, celebrates the role of the African Caribbean community in St Albans.

It will focus on the years between 1948 and 1971, though it will also refer to black residents from before this time and highlight achievements up to the present day.

Among the main themes are – Windrush and arrival, working lives, overcoming adversity, African Caribbean culture and commercial music.

The aim is to inspire the next generation and encourage people from diverse backgrounds to embrace their shared history.



Women Doing Everything, Everywhere, All At Once, Verulamium Museum, until Thursday 4 July, Free after admission charge.
