## **Policy Statement**

We are concerned about continuing reports by NGOs of a connection between the mining of certain minerals and the funding of armed conflict in the Democratic Republic of Congo (DRC).

The minerals are used to produce the metals: tantalum, tin, tungsten and gold and are often used when manufacturing electronic equipment.

These minerals are known as 'Conflict Minerals'.

We believe this issue will be most effectively addressed by working collaboratively with our suppliers and recognise the positive steps in the Global e-Sustainability Initiative (GeSI).

A joint initiative by GeSI and the Electronic Industry Citizenship Coalition (EICC) is working to establish validated conflict free sources of these minerals.

GeSI-EICC is working to increase the transparency and traceability of conflict minerals using a "bag and tag" programme.

We promote our conflict minerals policy to suppliers where appropriate and thereby encourage them to adopt similar policies towards eliminating conflict minerals in their supply chain.

#### Aim

St Albans City & District Council aim to move towards an IT equipment estate that is free from the use of any such 'Conflict Minerals'.

# Purpose

To set out guidelines for the procurement of IT equipment to work in conjunction with the policies and procedures already in place with our current suppliers.

#### Scope

#### Employees

- 1. The Policy applies to all employees of the Council, especially any area where IT equipment is procured.
- 2. This Policy should be read in conjunction with the Council's security guidance policy.

#### Residents

This policy has been provided to reassure residents of the district and provide information on the Council's approach to the use of conflict minerals.

#### Principles

- 1. The Council, in its purchase of IT equipment makes use of pre tendered frameworks designed to ease the burden of procurement for local authorities.
- 2. The suppliers on the list of the frameworks include Dell, HP, Viglen, SCC, Softcat, Tindirect and Dacoll.
- 3. The Council will check suppliers have an effective conflict minerals policy and plan for eradication as part of the equipment pre-purchase assessment. Where a supplier does not have an effective policy and plan then the Council will write to the prospective supplier requesting action be taken to become conflict mineral free. Subject to procurement constraints, preference will be given to suppliers that are conflict mineral free or have clear policies and plans to become so.

The Council will take reasonable steps to avoid suppliers who do not have the appropriate policies, plans and procedures in place to eradicate conflict minerals from their supply chain.

#### Roles and Responsibilities

- 1. Managers must ensure that they adhere to this policy and provide guidance to staff.
- 2. Employees need to be aware of this policy and renew their knowledge of it periodically.
