### **Introduction**

During the initial consultation stage of the Community Governance Review (CGR), a number of suggestions were made about community governance in the district. A report listing all these suggestions was submitted to the Policy Committee on 23 June 2022 and draft recommendations were agreed for a further round of public consultation. Details of all these draft recommendations are provided below.

### **Electorate forecasts**

The current electorate (June 2022) and predicted future electorate (for 2027) are provided against each draft recommendation. For background and further detail about the electorate forecasts, see appendix 9.

### **Colney Heath Parish Council**

Among the comments received by the Council were a number proposing that the area of Colney Heath Parish Council be reduced to match that of the District Council ward of Colney Heath. Such a reduction would leave residents of the Highfield Park and Hill End areas without parish representation.

**Draft recommendation 1:** to alter the outer boundary of Colney Heath Parish Council to match that of the Colney Heath District Council ward and remove parish representation from those residents of Hill End District Council ward who are presently represented on Colney Heath Parish Council.

The predicted electorate for 2027 of the current Colney Heath Parish Council area is 4690.

Therefore, the draft recommendation would decrease the predicted electorate of the parish by 2459 electors (52.43% of the predicted electorate for the current Colney Heath Parish Council).

### Sandridge Parish Council

At present the boundary of Sandridge Parish Council cuts across Rose Walk so that some properties are within the parish and others are unparished. For the sake of effective and convenient governance, it is proposed to alter the outer boundary of Sandridge Parish Council so that all properties in Rose Walk are part of that parish.

**Draft recommendation 2(a):** to alter the outer boundary of Sandridge Parish Council to include the presently unparished properties at numbers 1, 2 and 3 Rose Walk within the parish.

The predicted electorate for 2027 of the current Sandridge Parish Council area is 9126.

Therefore, the draft recommendation would increase the predicted electorate of the parish by 5 electors (0.05% of the predicted parish electorate of the current Sandridge Parish Council, and 0.09% of the predicted parish ward electorate).

**Draft recommendation 2(b):** to divide Marshalswick East & Jersey Farm Parish Ward into two parish wards.

The proposed Jersey Farm parish ward would contain 43.48% of the electors in the current Marshalswick East & Jersey Farm parish ward, while the proposed Marshalswick East parish ward would contain 56.52% of the electors. Therefore, the proposed Jersey Farm parish ward would be represented by 3 parish councillors and the proposed Marshalswick East parish ward by 5 parish councillors.

### **London Colney Parish Council**

The reasoning behind draft recommendations 3(a), 3(b), 4, and 5 was to once more align parish boundaries with district ward boundaries, following changes recently made by the Local Government Boundary Commission for England (LGBCE) during their review of district ward boundaries. We agreed that the LGBCE changes respected the identities and interests of communities and would assist in making community governance effective and convenient.

**Draft recommendation 3(a):** to alter the northern boundary of London Colney Parish Council to run along the A414 from the London Colney roundabout westward to its junction with the east midlands railway line, thereby including the following presently unparished properties within the London Colney Parish Council area: numbers 1-24 North Cottages, and 10, 12, 14, and 37 Suffolk Close.

Therefore, the draft recommendation would increase the predicted electorate of the parish by 61 electors (0.83% of the predicted electorate of the current London Colney Parish Council). The predicted electorate of London Colney parish ward would increase by 10 electors (0.16% of the predicted electorate for the parish ward). The predicted electorate of Napsbury parish ward would increase by 51 electors (4.00% of the predicted electorate for the parish ward).

**Draft recommendation 3(b):** to divide the London Colney Parish Ward into two parish wards.

The proposed London Colney North parish ward would contain 41.18% of the electors in the current London Colney parish ward, while the proposed London Colney South parish ward would contain 58.82% of the electors. Therefore, London Colney North parish ward would be represented by 3 parish councillors and London Colney South parish ward by 4 parish councillors.

### Harpenden Town Council / Wheathampstead Parish Council

The reasoning behind draft recommendations 3(a), 3(b), 4, and 5 was to once more align parish boundaries with district ward boundaries, following changes recently made by the Local Government Boundary Commission for England (LGBCE) during their review of district ward boundaries. We agreed that the LGBCE changes respected the identities and interests of communities and would assist in making community governance effective and convenient.

**Draft recommendation 4:** to alter the boundary between Wheathampstead Parish Council and Harpenden Town Council, so that all properties in Long Buftlers, Croftwell, Poynings Close, Aldwickbury School and numbers 82-104 (evens only) Wheathampstead Road, presently part of Wheathampstead Parish Council, become part of Harpenden Town Council.

Therefore, the draft recommendation would increase the predicted electorate of Harpenden Town Council / Harpenden South town ward by 173 electors (0.76% of the predicted electorate of the current Harpenden Town Council area / 3.21% of the predicted town ward electorate). The predicted electorate of Wheathampstead Parish

Council would decrease by 173 electors (3.46% of the predicted electorate of the current Wheathampstead Parish Council area).

### St Michael Parish Council / St Stephen Parish Council

The reasoning behind draft recommendations 3(a), 3(b), 4, and 5 was to once more align parish boundaries with district ward boundaries, following changes recently made by the Local Government Boundary Commission for England (LGBCE) during their review of district ward boundaries. We agreed that the LGBCE changes respected the identities and interests of communities and would assist in making community governance effective and convenient.

**Draft recommendation 5:** to alter the parish boundary between St Michael Parish Council and St Stephen Parish Council that presently splits Ragged Hall Lane so that the parish boundary follows the new District Ward boundary running along the A414 westward from its junction with Watford Road to Park Wood, thereby including 2-110 Ragged Hall Lane (evens only) and 74-84 Watford Road (evens only) within St Stephen Parish Council area.





The predicted electorate of St Stephen Parish Council / Bricket Wood & Chiswell Green parish ward would increase by 104 electors

(0.88% of the predicted electorate of the current St Stephen Parish Council area / 1.56% of the predicted parish ward electorate).


### Appendix 1a: Proposed Transfer of Properties from Colney Heath Parish to the Unparished Area






# Appendix 3: Transfer of Properties from Unparished Area to Sandridge Parish




### **Appendix 4: Proposed Parish Wards for Sandridge Parish**




### **Appendix 5: Transfer of Properties from Unparished Area to London Colney Parish**




### **Appendix 6: Proposed Parish Wards for London Colney Parish**

### **Background**

At the beginning of the St Albans City & District Community Governance Review (CGR), we calculated and published the predicted electorates per polling district for 2027. This was to account for any impact that population changes and housing development might have in the district within the next five years. The forecasts and accompanying methodology can be found on the CGR webpage (https://www.stalbans.gov.uk/community-governance-review).

Following an initial round of public consultation (4 January 2022 – 31 March 2022), the council has produced a series of draft recommendations prior to a second round of public consultation (1 July 2022 – 16 September 2022). To accompany these draft recommendations, we have calculated the effect that such changes may have on the electorate figures for the affected areas. Our calculations are based on the original predicted electorates for 2027 which we published at the start of the CGR. All forecasts are based on the local government electorate (i.e., those voters who are registered and entitled to vote in local government elections).

We are aware of the Local Government boundary Commission for England (LGBCE) view that it is not in the interests of effective and convenient local government, either for voters or councillors, to have significant differences in levels of representation between parish wards within a parish. We have considered the levels of representation between each ward after the proposed changes have been made and believe that any variation is acceptable.

#### Parish wards and councillor numbers

As part of their recent review of district ward boundaries in St Albans City & District, the LGBCE made some related changes to parish wards and parish councillor numbers. The details of these changes are contained in Article 5 and Schedule 3 of *The St Albans (Electoral Changes) Order 2021*, and come into force for the purpose of parish elections in 2023 (<a href="https://www.legislation.gov.uk/uksi/2021/900/contents/made">https://www.legislation.gov.uk/uksi/2021/900/contents/made</a>). These arrangements may be altered as an outcome of the CGR. Unless otherwise stated, the parish wards and councillor numbers that are referred to throughout these electorate forecasts relate to those listed in *The St Albans (Electoral Changes) Order 2021*.

### **Colney Heath Parish Council**

**Draft recommendation 1:** to alter the outer boundary of Colney Heath Parish Council to match that of the Colney Heath District Council ward and remove parish representation from those residents of Hill End District Council ward who are presently represented on Colney Heath Parish Council.

### **Electoral forecasts**

The current electorate (June 2022) of Colney Heath Parish Council is 4639.

**Draft recommendation 2(a):** to alter the outer boundary of Sandridge Parish Council to include the presently unparished properties at numbers 1, 2 and 3 Rose Walk within the parish.

### **London Colney Parish Council**

**Draft recommendation 3(a):** to alter the northern boundary of London Colney Parish Council to run along the A414 from the London Colney roundabout westward to its junction with the east midlands railway line, thereby including the following presently unparished properties within the London Colney Parish Council area: numbers 1-24 North Cottages, and 10, 12, 14, and 37 Suffolk Close.

### <u>Harpenden Town Council and Wheathampstead Parish Council</u>

**Draft recommendation 4:** to alter the boundary between Wheathampstead Parish Council and Harpenden Town Council, so that all properties in Long Buftlers, Croftwell, Poynings Close, Aldwickbury School and numbers 82-104 (evens only) Wheathampstead Road, presently part of Wheathampstead Parish Council, become part of Harpenden Town Council.
