3. If any election is contested the poll will take place on **Thursday 06 May 2021**

5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Electoral Services Office, St Albans City & District Council, Civic Centre, St Peters Street, St Albans, AL1 3JE by **5.00 pm on Tuesday 20 April 2021**

6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services Office, St Albans City & District Council, Civic Centre, St Peters Street, St Albans, AL1 3JE by **5.00 pm on Tuesday 27 April 2021**

7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity, for work/service reasons or attendance at a training or educational course must reach the Electoral Registration Officer at Electoral Services Office, St Albans City & District Council, Civic Centre, St Peters Street, St Albans, AL1 3JE by **5.00pm on Thursday 6 May 2021**. The physical incapacity must have occurred after **5.00pm on Tuesday 27 April 2021**. To apply on the grounds of work/service or attendance at a training or educational course, the person must have become aware that they cannot go to the polling station in person after **5.00pm on Tuesday 27 April 2021**
