Background


- 1. St Albans City centre sits on a hill adjacent to the Ver valley which allows for long-distance views of the historic city and its skyline. While the Cathedral and Abbey Church of St Albans dominates, there are other landmarks which punctuate the skyline, and the traditional clay and slate pitched roofs create a varied and interesting roofscape. The skyline is considered to be an important characteristic of the city which contributes to the significance of the St Albans Conservation Area, St Albans Abbey and other heritage assets; and the Council seeks to protect the most important skyline views.
- 2. The Council, in preparing evidence to inform a new Local Plan, identified a need to review and update the current planning policy that protects the roofscape and skyline.
- 3. The 'Current Local Plan Policy 114 St Albans City Centre, Building Height, Roofscape and Skyline (1994) Viewpoint Review' Paper to accompany St Albans Local Plan 2041 Regulation 19 Public Consultation; available via the Council's Examination Library at EDH 04.09; sets out:
 - Current Local Plan Policy (1994);
 - Current National Guidance and Other LPA Approaches
 - Approach for St Albans new Local Plan;
 - Scope of the work;
 - Methodology; and
 - Viewpoints and Summary of Recommendations.
 - 4. EDH 04.09 identified a total of 14no. viewpoints for use in the new Local Plan, which are either renewed or updated from the Current Local Plan (1994) viewpoints.
 - 5. Historic England (HE), in response to the Regulation 19 Local Plan, suggested that a number of other views should also be considered. In ongoing liaison with HE, the suggested additional viewpoints were all considered and then either scoped out or subject to detailed assessment using the same methodology as the other viewpoints considered in EDH 04.09. This Paper sets out the assessment of the 3 additional viewpoints which were agreed with HE to require further assessment: Sopwell Nunnery, Bacon's Mound and Gorhambury Estate Drive.

Additional Viewpoints and Summary of Recommendations

6. This additional viewpoint recommendations are summarised in the table below and shown on Figure 2:





Description:	A set of medium / long distance static / transient views along the Drive. Depending on the location along the drive the view will be either full or partial given the avenue of trees along the drive. The Abbey is the dominant feature of the skyline due to its size and extension above the vegetation skyline. The other landmark buildings are smaller in height but still extend above the vegetation skyline allowing them to be prominent in the views.

	The Drive has permissible rights for pedestrians however it is not fully accessible to the public, and careful consideration should be given as to whether it is suitable for inclusion.
