6. Round Table

• **Planometer:** MW to invite updates to the Planometer prior to the next meeting.

Action: Districts to continue providing Planometer updates.

- **North Herts** sustainability SPD progressed to consultation, continuing work on strategic site delivery
- **East Herts** has appointed principal urban design officer, likely call for sites in April (trying to digitise the process as much as possible, got some funding), sustainability officer starting in a few weeks, open spaces work with SBC and NHDC, finalising
- **Welwyn Hatfield** Legal challenge to the Local Plan (adopted October 2023), first matter to be considered is whether the claimant (a local developer) severed the claim within time to the defendants (Council and SoS), likely to have an oral hearing on this single matter after March, date TBC. Exploratory work starting on visioning and aspirations for the Local Plan review. Working on CIL and Sustainability SPD alongside masterplans for strategic sites
- Hertsmere Regulation 18 consultation commenced earlier in the week (3 April) and will
 run for six weeks. A series of engagement events will be held around the borough. Reg 19

in late 2024.

- **Three Rivers** Local Plan is the focus, new LDS published (March), Reg 19 in the Autumn with submission in early 2025.
- Dacorum Nothing to note this time other than continued involvement on matters Luton
 Airport
- HCC Minerals and Waste Minerals and Waste Team is waiting for news on the Hatfield
 Aerodrome appeal. It is hoped that the Reg 19 Plan will be published for consultation by the
 end of the calendar year
- **Watford** Local Plan over one and half years old, currently not planning to review. Looking at several SPDs, however cautious of changes at National level. Developer contributions and BNG are topics being explored. Looked at some design work for sites in Local Plan in terms of major constraints/opportunities, leading to design coding (that wont be done in house). Been reviewing appeals to see where weaknesses are in LP. A4D confirmed in Christmas. SWH doing joint studies for housing and employment.
- **Planner Directory:** A number of updates to the Directory were provided.

Action: Districts to continue providing Directory updates as required.

7. Joint Strategic Plans Update

- **SW Herts Joint Strategic Plan:** LW updated the group. Developed strategic growth principles based on vision work and leading into areas of map. Intention is this work will feed into reg 18 for JSP.
- **NEC Herts Joint Strategic Plan / Growth Study:** MW updated the group. The North East Central Hertfordshire (NEC Hertfordshire) authorities, together with Hertfordshire County Council, have jointly commissioned a cross-boundary growth study for the NEC Hertfordshire area. Stage 1 complete but paused to allow some visioning work to take place. This is now complete and will be the subject of focused consultation in due course before the Stage 2 of the Growth Study commences. The key aim of the commission is to support NEC Hertfordshire authorities in developing a series of place-based sustainable growth options that will form a critical piece of the evidence base to support a potential Joint Strategic Plan (JSP) for the period up to 2050. Heads of Planning considering options for next steps.
