

### Privacy Notice

This privacy notice explains how St Albans City & District Council (the Data Controller) will use any personal information we collect about you when you use our services.

### What information do we collect about you?

The information we will collect will vary depending on how you use the Council's Services. We collect personal information you agree to share with us voluntarily so that you can nominate in the St Albans Mayor's Pride Awards. You will be asked to provide your contact details. You are choosing to share your personal information. This means you are giving us consent to use your personal data for this consultation (Art. 6(1)(a) GDPR). **The information you provide about the person you are nominating will be publicised if the nominee is shortlisted. Please consider this when completing the nomination form and ensure you only share personal data about the nominee which can be publicised.**

### How will we use the information about you?

If you complete this form the information you provide will be used to enable the Council to contact you with information about the St Albans Mayors Pride Awards. We will ensure that all personal information is kept securely. We will share the nominations with the panel of judges. We may contact nominees to invite them to the awards ceremony and other purposes connected with the Mayors Pride Awards.

### How long will you keep this information?

We will destroy this personal information in accordance with our Disposal Schedules. This means we will securely destroy the information once we no longer need it. ### Access to information and correction

You have a right to request a copy of the personal information that we hold about you. If you would like a copy of some or all of your information, please contact [foi@stalbans.gov.uk](mailto:foi@stalbans.gov.uk) and ask for a subject access request.

You have the following rights in respect of the information you have consented to share with us:

- To be forgotten i.e. your details will be deleted
- To have us correct an error
- To have us restrict the way we use the information
- To object to us using the information
- To have your information shared at your request (data portability)
