Re – Burston Garden Centre 5/2020/3022 – Your ref. P01362250

I write to you as the heritage consultant acting for the applicant, Castle Oak Developments, in reference to your consultation response of the 2nd March 2021.

I must admit a degree of surprise at a response, in that this is the first substantive comment from Historic England regarding the site and that the current application is the least impactful of numerous schemes previously brought forward by CastleOak, including in an extensive pre-planning process.

Now that Covid-19 provisions are being somewhat relaxed I think that it would offer an ideal opportunity to meet on site. You would be able to see the condition of the site as is currently the case (numerous industrial sheds close to the grounds of the heritage asset) and the degree of legibility of the asset's significance from the site (somewhat restricted). Do let me know when you might be available and I can arrange a suitably Covid-distanced meeting on site to talk through the case.

I also wondered if you were aware of the enforcement case that the LPA are currently prosecuting in relation to the heritage asset? I understand that the previous owner had stripped out many original features; I am not clear on how this has affected the asset's significance.
