Independent Remuneration Panel Members

Would you like the opportunity to have an input into decisions on the level and types of payments made to St Albans City & District Councillors?

Our Council is made up of 56 elected Councillors who are entitled to receive payments in the form of allowances and expenses to compensate them for the work that they do and the responsibilities they assume on behalf of the communities they serve. In addition to receiving reimbursement of travelling and subsistence allowance, the payments to elected Councillors comprise of a "Basic Allowance" which is paid to all Councillors to reflect the roles that they undertake and "Special Responsibility Allowances" which are paid to those Members who carry responsibilities within the Council's constitutional arrangements.

Councils cannot alter or update their existing Schemes of Members' Allowances without first considering recommendations from an Independent Remuneration Panel; a Panel of completely independent people who consider the roles undertaken by Councillors and make recommendations as to the amount they should receive in Basic and Special Responsibility Allowance.

We are looking for members of the public to join our Independent Remuneration Panel for a four-year term of office.

Applicants must have:

- Some knowledge and interest in the work of the Council.
- Sound judgement and decision-making skills, with an ability to remain impartial and objective.
- Flexibility, in terms of being able to attend meetings of the Panel.
- Some knowledge of the role of Councillors would be an advantage but is not essential.

Please note you are not eligible for appointment to the Panel if:

- You are a member or officer of St Albans City & District Council including Parish & Town Councils in the St Albans City & District area.
- You are the subject of a bankruptcy restriction order, an interim bankruptcy restrictions order, a debt relief restriction order or interim debt relief restriction order.
- You have within five years been convicted in the United Kingdom, the Channel Islands or the Isle of Man of any offence and have been sentenced to a term of imprisonment (whether suspended or not) for a period of not less than three months.
- You are disqualified from being elected or for being a member of an authority under Part III of the Representation of the People Act 1983
- You are subject to any relevant notification requirements, or a relevant order relating to sexual offences.

Commitment

- Appointments will be made for a four-year period.
- Meetings will be held, usually during the day, either at the Council offices in St Albans or via a MS Teams meeting.
- A reasonable estimate is that the Panel may need to meet no more than four times per annum for approximately one/two hours each time.
- An annual payment is provided to cover expenses incurred for attending Panel meetings.

PUBLIC NOTICES

[Note: this Notice is about proposals to convert free limited waiting parking places in Harpenden and St. Albans to paid parking places with 20-minute free parking and disabled persons parking places. Objections and other comments may be made – see paragraph 5].

- 1. NOTICE IS HEREBY GIVEN that St Albans City and District Council (pursuant to arrangement made with Hertfordshire County Council) proposes to make the St. Albans City and District Council (Control of Parking) (Amendment No. **) Order 2024 under the Road Traffic Regulation Act 1984.
- 2. The general effect of the Order would be in Harpenden to: -
- (1) Amend the operation of existing disabled persons parking places to at any time 3-hour maximum stay no return in 2-hours in (a) Amenbury Lane, (b) Arden Grove, (c) Bower's Parade, (d) Bowers Way, (e) Church Green, and (f) Vaughan Road;
- (2) Convert free limited waiting parking places to disabled persons parking places to at any time 3-hour maximum stay no return in 2-hours in (a) Bowers Parade, (b) Leyton Green, (c) Station Road, and (d) Vaughan Road,
- (3) Convert free limited waiting parking places to paid 2-hour maximum stay no return within 2-hours parking places operating Monday to Saturday between 8am and 6pm in (a) Arden Grove, (b) Bower's Parade, (c) Church Green, (d) High Street, (e) Kirkdale Road, (f) Leyton Green, (g) Leyton Road, (h) Station Road, (i) Thompsons Close, (j) Southdown Road, (k) Vaughan Road, and (l) Victoria Road.
- (4) Convert free limited waiting parking places to paid 2-hour maximum stay no return within 2-hours parking places operating Monday to Saturday between 8.30am and 6pm in High Street outside No. 10 High Street.
- (5) Remove the part-time evening taxi parking at the location in (4) above.
- 3. The general effect of the Order would be in St. Albans to: -
- (1) Convert free limited waiting parking places to disabled persons parking places to at any time 3-hour maximum stay no return in 2-hours in (a) Victoria Street.
- (2) Convert free limited waiting parking places to paid 2-hour maximum stay no return within 2-hours parking places operating Monday to Saturday between 8.30am and 6.30pm in Drovers Way, Victoria Street, Lattimore Road, London Road.
- (3) Convert free limited waiting parking places to shared use (permit [S] holders and paid 2-hour maximum stay no return within 2-hours parking places): -
 - (a) operating Monday to Saturday between 8am and 6pm in Clarence Road and York Road;
 - (b) operating Monday to Saturday between 8.30am and 8pm in London Road.
- 4. The proposed charges will be up to 20 minutes free (2 free sessions per vehicle per day), up to 1 hour £2.50, up to 2 hours £5 and are necessary to effectively manage the control and turnover of limited waiting parking places.
