#### **Invalid Applications Administration Fee**

Applicants and Agents are encouraged to read the Validation guidance document which we have published on the Council's website prior to submitting planning applications, as minor changes can happen between major revisions of the guidance. Please note if an application is made that fails to meet our validation requirements, an invalid application charge will be made. If the information required to make the application valid is not received within 14 days of a written request for further information, we will dispose of the application and deduct a charge of £25 for householders, £75 for minor/other and £175 for major applications from the planning fee submitted before returning the balance.
