3. The Matters Which Appear To Constitute The Breach Of Planning Control It appears to the Council that the following breach of planning control has occurred within the last 4 years. Erection of outbuilding at rear of the site.

4. Reasons For Issuing This Notice

"The outbuilding is a dominant, overbearing and visually intrusive development which by reason of its size, bulk, height and proximity to neighbouring boundaries is out of keeping with and detrimental to the character and appearance of its surroundings.

The development is contrary to Policies 69 (General Design & Layout) and 72 (Extensions in Residential Areas) of the St Albans District Plan Review 1994."

5. What You Are Required To Do

Remove the structure from the site making good any damage and disposing of resulting materials in the appropriate manner.

6. Time For Compliance

2 months after this notice takes effect.

7. When This Notice Takes Effect

This notice takes effect on 10 November 2010 unless an appeal is made against it beforehand.



Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
