> TPO reference for the trees is 1369, which covers all the trees in Oster and Thornton Street, St Albans. Both streets are private and unadopted. The trees this application relates to is T16 and is outside No 8 Thornton Street, St Albans.

If regular pruning is not carried out the branches begin to sag and head

clearance for pedestirans walking on the pavement is impeded. The branches on the roadside of the tree also affect vehicles, restricting parking and causing potential damage to paintwork. The taller branches can also get caught on high sided vehicles such as rubbish collection lorries and delivery vans when not cut back. In addition the pavements and parked cars get covered in a very sticky sap

that is produced by the trees.
