

Privacy Notice – Claims against the Council

How will we use the information about you?

We use the information to deal with your claim accordingly. We may share the information with other departments at the Council to enable us to deal with your claim. We will only share the information to enable us to deal with this matter.

We will share the information you provide with our insurers and their partner organisations to manage the claim. If your claim relates to highway matters, we may share the information with Hertfordshire County Council.

We will not share the personal information we hold with any external organisations except for partner organisations. By partner organisations we mean contractors that are relevant to the nature of the claim and where sharing your data is necessary to deal with your matter. We may be required to share your personal information with the Police, Internal Audit or similar agency, or another Council for the purposes of preventing and detecting fraud.

We may share the personal information you provide with CIFAS for the purpose of fraud prevention. They may share this with other organisations including fraud agencies and local authorities which are specified on their [website](#).

If any of the information you provide is inaccurate or if fraud is detected, this may affect your ability to access certain services from us. Anyone knowingly making a false statement may be liable to prosecution. We will also share your personal data with CIFAS. CIFAS may share it with other organisations and they could be refused certain services, finance or employment as a consequence. We will ensure that all personal information is kept securely.

How long will we keep this information?

We will destroy this personal information in accordance with our Disposal Schedules. To determine how long we should keep information, we consider what the legislation states and what is good practice. This means we will securely destroy the information once we no longer need it. CIFAS and other fraud agencies will retain your personal information in accordance with their disposal schedules, this can be up to a period of six years. Fraud prevention agencies such as CIFAS may transfer your data outside of the European Economic Area (EEA), however they will impose contractual obligations to protect your personal data if they do this.

Individuals' Rights

The General Data Protection Regulation gives you specific rights to control your information. The extent to which these rights will apply to you depends upon the nature of your claim. In all cases you have a right to request a copy of the personal information that we hold about you. If you would like

a copy of some or all of your information, please contact foi@stalbans.gov.uk and ask for a subject access request.

If you consider we hold inaccurate personal information about you, you can contact us to ask for this information to be corrected. You also have a right to ask us to restrict what we do with your information. We may not be able to restrict it but we will consider your request.

If you consider we hold inaccurate personal information about you, you can contact us to ask for this information to be corrected. We will consider your request and respond within one month. Please contact GDPR@stalbans.gov.uk.
