Privacy Notice - Noise, bonfire and odour complaints

This privacy notice explains how St Albans City & District Council (the Data Controller) will use any personal information we collect about you when you use our services.

What information do we collect about you?

The information that the Council will collect varies depending on how you use the Council's Services. We are using the information provided in this case because we have a legal obligation Art. 6(1)(c), public task Art. 6(1)(e) and consent Art. 6(1)(a) of the UK General Data Protection Regulations ("UK GDPR")). This means we collect your personal information from you so that we can carry out a function we are required by law to carry out; provide a service we choose to provide or carry out processing where you have agreed to share the data with us. In each case we are collecting personal information we will tell you the reasons on a privacy notice.

If you are providing us with special category personal information (such as details about your health) we will be processing this under Art.9 (2) of UK GDPR. If you are providing us with criminal conviction personal information we will be processing this under Art. 10 of UK GDPR.

How will we use the information about you?

We use the information to process your complaint(s). We may share the information with other departments at the Council to enable us to deal with your complaint but for no other purposes.

We will not share the personal information we hold with any external organisations unless the matter proceeds to Court. We will share the details of the complaint(s) with the person complained of, but not your personal details.

We may be required to share your personal information with the Police, Internal Audit or similar agency, or another Council for the purposes of preventing and detecting fraud. We will ensure that all personal information is kept securely.

How long will we keep this information?

We will destroy this personal information in accordance with our Disposal Schedules. To determine how long we should keep information, we consider what the legislation states and what is good practice. This means we will securely destroy the information once we no longer need it. Individuals' Rights

You have a right to request a copy of the personal information that we hold about you. If you would like a copy of some or all of your information, please contact <u>foi@stalbans.gov.uk</u> and ask for a subject access request.
